SECRETARY'S REPORT

The 2020 winter season was to be the year we celebrated our 75th year of playing the game we love. Preparations for these festivities were in the early stages, but we looked forward to celebrating our history and all of our past and present members.

In February 2020, the Dandneong Baseball Association held their Annual General Meeting in preparation for the upcoming season. At this time, information about the COVID-19 pandemic was still coming in from the government and health organisations, and many governing bodies were cautious about allowing community sport to go ahead.

In March, Baseball Victoria postponed all on and off-field baseball activity and we were unable to continue our preparations for the 2020 season. This postponement went on for a few months and was lifted around the end of May.

At this time, we had appointed a club coach in Ricky Wheeler, and Mark Richards had been focusing on increasing and supporting our junior players. We were fortunate enough to run some training sessions for both senior and junior players (while complying with COVID regulations set by BV and the government). These sessions were well attended by both age groups, and the proposed shortened season looked promising for the club.

In early July, Baseball Victoria cancelled all baseball activity across the state. This decision saw some disappointed junior players who were very much looking forward to getting out on the diamond and stopped the club from being able to celebrate its 75 years of playing.

While we dealt with the on-and-off elements of the season, there were still a number of people at work behind the scenes preparing for everything to go ahead. I would like to thank Mark and Annette O'Brien, Tim Hanson, Peter Gloury, Rob Bowen, Ricky Wheeler, Mark Jones and Mark Richards for their work and assistance in prepping the club and its players to getting back on the field.

Additionally, we had a crew of people come down (when circumstances allowed) to work on the diamond to have it ready for play, along with some great support from junior parents assisting with their training sessions. Thank you all for your work and time, it was greatly appreciated.

We hope that in 2021 community sport will return and we will once again be in a position to give our members a great season, both on and off the diamond.
